



## AIRTIGHT SPRAY FOAM INSULATION 25 YEAR LIMITED WARRANTY

Lapolla Industries, Inc. (“Lapolla”), subject to the conditions and limitations listed herein, warrants that Foam-LOK™ spray polyurethane foam systems, consisting of Foam-LOK CC Closed-cell Spray Foam Insulation, and Foam-LOK OC Open-cell Spray Foam Insulation (the “Products”), when installed according to the installation instructions by an approved spray polyurethane foam applicator, will perform as indicated in the Products specification sheet published at the time of shipment for 25 years (the “Limited Warranty”). In order for this Limited Warranty to become effective, the original purchaser must register with the Lapolla Warranty Department within 30 days of occupancy.

Lapolla’s sole responsibility under this Limited Warranty shall be to repair or replace any defective Products at the original invoiced value of the material. Lapolla shall not be responsible for labor costs or any other costs whatsoever in connection with the removal or installation of either the original or replacement insulation.

Lapolla shall have no liability under this Limited Warranty for defects or failure caused by improper storage, or an installation not in strict adherence with its written instructions, or any damage due to fire, storms, other Acts of nature, abuse, neglect, or accident, or defects, failure, or damage caused by materials adjacent to the Products, or damage caused by alteration after completion of the installation of the Products. Statements about the performance qualities of the Products by qualified spray polyurethane foam contractor or contained in advertising literature do not constitute an express warranty.

THIS LIMITED WARRANTY IS MADE IN LIEU OF ALL OTHER WARRANTIES, WHETHER ARISING UNDER STATUTE, OR IN TORT, OR BY IMPLICATION OF LAW OR OTHERWISE. ALL IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY. LAPOLLA SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM A BREACH OF ANY EXPRESS OR IMPLIED WARRANTY OR FOR THE COST OF REMOVING, INSTALLING, OR REINSTATING ANY REPAIR OR REPLACEMENT.

Some jurisdictions do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Limited Warranty gives you specific legal rights, and you may also have other rights, which vary from jurisdiction to jurisdiction.
